





4. Jurisdiction

The Registrar under whose jurisdiction the society will be
functioning is Mysore.

5. The working hours of the, 10 a.m to 12 noon on First Wednesday of
the month.

6. Objects of the Society :

the provision and maintenance of churches, seminaries,
missionaries, educational and industrial institutions, hostels, poor
houses, parishes and general for any other religious social an
charitable purposes or otherwise as in the opinion of the governing
body will be conducive to the maintenance and advancement of the
spiritual and material interests of the Roman Catholic Mission in
said Diocese of Mysore.

7. Activities of the Society in furtherance of its objects:

The members of the general body shall meet whenever necessary
in furtherance of its objects.

8. All legal proceedings whether instituted by the Society or against
the Society shall be conducted by the Treasurer of the Society.

9. The President shall be Chairman Executive of the Society and is
empowered to give directions in regard to the activities of the
Society.

10. Enrollment of Members:

Removal of Members:

Membership of the Society shall be lost if any member ceases to such member as a result of renunciation, removal or death.

Rights, Obligations and privileges of the Members:

Members shall be entitled to all Rights and privileges accorded them under the rules governing the Catholic church and with refer to the Institutions established and administered by the Society right to preferential consideration for employment in the various Institutions established and administered by the Society and to be and officiate as Members of the Board of Management of such Institutions and Agencies if and when so appointed. Every member being primarily a person of Religion shall abide by and agree to by all the Rules and Regulations and Discipline of the Catholic C Every member while being entitled to the rights and privileges attached to the Membership of the Catholic church, shall be bound the decision of the President in all matters, which shall be final and which shall not be called in question in any Court or Tribune

13. THE PARTITION OF BURMAH

The Governing Body under the direction and control of the pres-
ident shall transact the business of the Society through the Treasurer
of the Society.


14. The Governing Body:

The Governing Body shall consist of 7 members. The General Body shall at the Annual Meeting elect members for the Governing Body. They shall hold office for a period of three years from the date of appointment without prejudice to their right of reappointment.

In the event of a vacancy occurring among the members of the Governing Body either upon transfer, resignation or death, such vacancy shall be filled by the president within three months from date of such vacancy, in the case of the president the appointment of the new Bishop.

The Governing Body shall be subscribers to the Memorandum of Association.

The members of the Governing Body shall be the president of the trustees and acts as beneficial owners.

All property of the Society movable and immovable shall be in the Government Order and all documents relating thereto, shall be property of the Society; shall be taken and stored in the name of the Society and all such documents shall be executed for and on behalf of Society by the president or a member of the governing body, informed to him in writing for the purpose when and of appointment shall be mentioned in the document executed.

The Governing Body shall have full power to manage the affairs of the Society and to administer all property and to do all acts which its opinion may be conducive to the attainment of the objects of the Society in particular, through the treasurer of the Society.

It may sell, lease out, exchange, mortgage or otherwise alienate the property or any part thereof and apply the proceeds in any manner and for such purposes as it thinks fit for promoting the objects of the Society.

It may through the said treasurer pur chase, take, buy or mortgag e or in any way acquire immoveable property or any rights on property.

It may through the said treasurer borrow or raise money in such manner as it shall think fit and secure the payment of any money so or raised by the Society by mortgage, charge or loan upon the whole or any part of the Society's property or assets and give to lenders or creditors powers of sale and all other usual and necessary powers.

It may through the said treasurer enter into bonds contracts and agreements of any sort and secure the repayment of money both principal and interest, owing to the Society in any manner what so ever and give receipts for the same.

The president of the Society shall also have power to purchase sell, enclose, transfer and negotiate in every way securities, stock and share of every description, bank shares included, on the money market or otherwise, for and on behalf of the society.

In all transactions it shall not be required or demanded from the treasurer of the Society, the production of any written

Delegation or power of Attorney by the Governing Body, or of the person or persons special resolution passed by the said Governing Body, empowering him to enter into and conclude any such transaction and do all the requisite acts necessary in such transaction.

The Governing Body shall be answerable for the maintenance of the churches, seminaries, missionaries, schools, orphanages, hostels and boarding establishments, and other charitable institutions. Notwithstanding the creation of parish societies, which are given the charge of the schools as their correspondents, and the charge of other religious or charitable institutions, the maintenance, supervision and over all control of the above schools and other religious and charitable institutions shall be with the Governing Body of the P.C.Diocease of Kottayam. Fulfilment of all conditions of recognition by the Department of Education in accordance with the provision and rules enacted by the State, shall be with the Governing Body of the P.C.Diocease of Kottayam.

The educational and their charitable institutions not handed over to any parish society, but retained by the P.C.Diocease, or hereafter to be created as the Diocesan institution, shall be the sole concern of the Diocese.

The property of the Society mentioned above includes all the churches, chapels, schools, houses and all their movables and appurtenances, as well as all the lands administered by the Bishop of Kottayam and priests working under him, according to the rules of Canon Law, and not assigned to any parish society and means all the property that has been acquired or which will be acquired by the Bishop of Kottayam and his priests according to Canon Law for the benefit of the Kottayam Diocease.

15. Preparation and Filing of Returns with the Concerned Registrar.

The President of the Society shall arrange for the preparation and filing of an Audited Annual Statement of Accounts showing receipts and disbursements and Income and Expenditure for the year, a balance sheet and such other returns, statements and declarations as may be prescribed by Law with the concerned Registrar of the Society.

6. Audit of Accounts:

The accounts of the Society shall be duly audited by qualified Chartered Accountant and the Statement of accounts accompanied by Balance Sheet and Auditor's report shall be laid before the General Body not later than three months after the expiry of the financial year to which the accounts relate.

7. Supply of Copies of By-laws and Statements to Members:

Books of the Society like register of members, minute books and accounts of the Society and By-laws shall be made available for inspection of the members free of charge but after a demand with a week's notice in writing at the registered office of the Society.

A copy of the Society's By-laws etc will be supplied to the members of the Society at the cost of Re.1 for each copy.

8. Accounts to be maintained by the Society:

- (a) Cash Book, (b) Receipt book, (c) Vouchers file, (d) ledger
- (e) monthly register of receipts and disbursements.

10. Mode of Custody, application and Investment of the funds:

Subject to the provisions of section 24, a Society may also invest or deposit any portion of its funds not immediately required

(i) in a special account opened by the society for the purpose in any other banking company as defined in the Banking Regulation Act, 1949 (Central Act X of 1949); or

(ii) in "Units" issued by the Unit Trust of India; or

(iii) in securities of undertakings of the Government or the Government of India.

11. Fund earmarked for making provisions for a dependent of a deceased or disabled member:

No part of the funds of the Society shall be given to a dependent of a deceased or disabled member as such contingencies are not likely to arise in the context of the Society.

A. Annual General Body Meeting:-

(a) The Secretary in implementation of the directives of the President in this behalf shall convene the General Body Meeting of the Society within 3 months after the expiration of the financial year and place before the General Body Meeting held in the month of June.

- (i) The Annual Report of the Society.
- (ii) The Statements of receipts and expenditure and the balance sheet together with the report of the Auditor duly signed by the Auditor and the members of the Governing Body.
- (iii) Budget of Receipts and expenditure for the next year.

(b) Notice of every General Body Meeting of the Society shall be given to the Members at least 21 days before the day appointed for the meeting. The notice shall specify the day, the hour and the place and the object of the meeting and in case any amendment of a by-law or object of the Society as contained in the Memorandum is intended to be proposed, shall contain copy of such amendment.

The Notice shall be sent by post with certificate of posting. The Notice shall also be affixed to the notice board of the Society.

(c) The quorum for an Annual General Body Meeting shall be 1/2 of the total number of members rounded off to the next whole number provided that in the absence of the quorum the meeting shall stand adjourned to the next week on the same day and the meeting shall be conducted irrespective of a quorum being present or not.

All decisions shall normally be by a simple majority of the members present and voting and in case of special resolutions the majority required shall be 3/4 of the number of members present and voting.

(d) The Secretary of the Governing Body of the Society shall file with the Registrar within one month after the date of such General Body Meeting:-

- (i) An authenticated copy of each Receipt and Expenditure account, Balance Sheet and report.

- (ii) A statement of the names and addresses and occupation of the persons who, at the expiry of the financial year, were members of the society.
- (iii) A declaration to the effect that the Society has been in operation during the financial year.

5. Extraordinary Meeting:

The Governing Body acting through the Secretary may call an extraordinary General Body Meeting of the Society whenever needed.

Such Meeting shall also be convened by the Secretary in consultation with the President within one month from the date of receipt in writing from not less than one third of the members of the Society.

Notice of such Extraordinary General Meeting shall be given by the Secretary to the members as in the case of General Body meeting of the Society.

6. Special Resolution:

(a) The Secretary shall pass special resolutions for the following:

- (i) Amendment of objects and purposes of the Society.
- (ii) Amendments of Bylaws, rules and regulations of the Society.
- (iii) Removal of any officer-bearer.
- (iv) Amalgamation with another Society or division or dissolution of the Society.

b) 21 day's notice shall be given in respect of meetings called to pass special resolutions.

c) The Secretary shall register such special resolution amending the Memorandum or Bylaws with Registrar within 15 days of passing of the resolution.

23. The Registers of Members, the Books containing minutes and the book of account shall be kept at the Registered Office of the Society, during business hours for inspection by the members free of charge.

24. In the event of dissolution of the society, no part of the surplus funds left after the discharge of all its liabilities be divided among members, but such surplus funds can be transferred

25. In all matters not specifically provided for herein, the Societies Registration Act and rules framed thereunder shall apply.


